CALIFORNIA DISTRICT 24 2025 DISTRICT ALL STAR TOURNAMENT GUIDELINES

1. The teams and umpires shall arrive at the playing field at least sixty minutes (1 hour) prior to game time and be warmed up and ready to take infield thirty (30) minutes before game time.

2. MANAGERS and/OR COACH: A CA DL must be shown to the site director to pick up your approved tournament book for your first game.

3. Approved tournament affidavits and boundary maps, along with each player's documentation, to include the Tournament Player Verification Form, the Proofs of Residence (3), and any applicable waivers or proofs of school enrollment, **MUST** be turned into the Tournament or Site Director **sixty minutes (1 hour) prior to game time**.

4. Home team designation will be determined by a coin toss conducted by the Tournament Staff with Team Managers **sixty minutes (1 hour) before game time.** Home team shall occupy the third base dugout.

5. <u>BASEBALL</u>: Each team will provide three (3) new regulation Little League approved RST baseballs per each tournament game played.

SOFTBALL: Each team will provide two (2) new regulation Little League approved softballs per each tournament game played. (11-inch for 8/9/10 and 12- inch for all other divisions of softball)

6. District 24 will be supplying the line-up sheets. Four (4) copies of your teams' line-up must be given to the Tournament or Site Director **30 minutes before** game time. <u>NOTE:</u> All players, along with the manager and coach (es) that are listed on the team's affidavit, must be listed on the line-up sheet. The information required on each line-up sheet is to include the player's first and last name, along with the player's position number and his/her jersey number. If a player, that is on the affidavit, is not in attendance at a game, the word "Absent" must be written beside the player's name on the teams' line-up.

7. Tournament Rule 3(f)/Softball 3(g)-Managers or Coaches <u>are not permitted</u> to warm up a pitcher at home plate or in the bullpen or elsewhere at any time. They may stand by to observe a pitcher during warm-up in the bullpen.

8. Tournament Rule 3(g)/Softball 3(h)-Umpires are not required to inspect equipment prior to the start of the game. The managers of both team will confirm with the umpire(s) at the plate conference that all equipment is proper and legal according to Little League Rules. PENALTY: if illegal equipment is used during the game, the manager of the team will be removed for the

remainder of the International Tournament, the player who used the illegal equipment will be ejected from the game.

9. Tournament Rule 9 – Mandatory Play and Continuous Batting Order will be used.

10. MANDATORY PLAY VIOLATION: <u>Managers are solely responsible for ensuring all players fulfill the</u> requirements of mandatory play, even if notification is not made.

a. There is NO exception to this rule unless the game is shortened for any reason. <u>A game is</u> not considered shortened if the home team does not complete the offensive half of the sixth or seventh inning (or extra inning) due to winning the game.

11. <u>The game strategy shall be conducted from the dugout</u>. Conversation from the dugout with spectators may result in the offending player, coach, manager being removed from the game.

12. There will **NOT** be any special seating provided for the team scorekeeper. <u>All changes will be given to</u> the official Scorekeeper with the Plate Umpire present. The opposing manager can be present if they so choose. These changes will then be announced.

13. At the discretion of the District Administrator, only approved, official, newspaper photographers may be on the playing field during the game.

14. Managers, coaches, and players are to conduct themselves in a professional manner at all times. If you disagree with the umpire's decision, it is expected the correct and appropriate procedure will be used in discussing the matter. Managers or coaches cannot wear cutoff shorts or tank tops. Flip-flops/open-toed shoes will not be allowed. The dress code shall be neat and appropriate for a Little League Representative.

15. THE USE OF FOUL LANGUAGE, GESTURES or making of derogatory remarks WILL NOT BE TOLERATED. <u>PENALTY:</u> *This shall be cause for immediate removal of the offender from the game.*

16. Disruptive behavior by the spectators will not be tolerated and will be cause for removal of the offender(s) from the ballpark.

17. Teams are expected to hustle on and off the field...one (1) minute between innings.

18. Additional ground rules pertaining to specific playing field adjustments or expected conduct of team members will be discussed at the opening plate conference with the game umpires.

19. Only the rostered team manager, two (2) rostered coaches (if applicable), and a maximum of fourteen (14) rostered players (sixteen (16) rostered players for Senior Baseball only) shall be permitted in the dugout. <u>Mandatory play is in effect for all divisions EXCEPT the Senior division</u>. **All other persons shall occupy the identified spectator area**.

20. Any jewelry worn by a player that poses harm or injury will be subject to removal. This rule applies regardless of the composition of such jewelry, hard cosmetic item, or hard decorative item. Hard items to control the hair, such as beads, are permitted. Exception: Jewelry that alert medical personnel to a specific condition is permissible.

21. Once the game begins, **NO PLAYER, COACH, OR MANAGER** may leave the dugout without the permission of the Umpires. Stepping outside of the dugout for a smoke will constitute leaving the dugout without permission and that person will be prevented from re-entering the dugout for the remainder of the game. <u>During the game, teams *will not* be permitted to meet outside of the dugout.</u>

- **22.** Restroom privileges will be permitted providing:
 - **a.** Permission is first obtained from a game umpire.
 - b. The individual goes directly to and from the restroom without engaging in conversation with spectators. Up to two (2) designated parents from each team (FOR ALL DIVISION OF BASEBALL/SOFTBALL), determined prior to start of the game, will be allowed to accompany the team's players to the restroom.
 PENALTY: Offender may be removed from the game.

23. Electronic Recording devices on a tripod can be used, but cannot be attached to the ball field fence. EX: GO PROS or CELL PHONES.

24. Electronic devices will be restricted per Rule 3.17. Use of Game Changer will be permitted. Exception: A manager or coach is permitted to use one-way electronic devices from the dugout to the catcher while the team is on defense for the purpose of calling pitches. A manager or coach is prohibited from using the device to communicate with any other team member while on defense or any any team member(including a manager or a coach) while on offense, and a manager or coach shall not use the device outside the dugout/bench area.

25. "BALL BUCKETS" & DUGOUT GATES: Sitting on a "*ball bucket*", in any opening of a dugout, will **NOT** be allowed. If there is a gate door on the team's respective dugout area, for safety reasons, it will remain closed during the game unless used for entering or leaving the dugout.

26. PITCH COUNT-Baseball: [Tournament Rule # 4] shall apply. *The Pitch Count will be announced at the end of each inning.* The Official Scorekeeper shall notify the Umpire-in-Chief when the current pitcher has only 5-6 pitches left before he/she reaches the pitch count, which will be dependent on the age of the pitcher. The Umpire-in-Chief will notify the respective manager. <u>*This assistance will NOT relieve the manager of the responsibility of fully observing this regulation.*</u>

PENALTY: Failure to remove a pitcher who has reached his/her maximum number of pitches required by league age or use of an ineligible pitcher is basis for protest. **Violation protested and brought to the attention of the Tournament Committee, shall result in the suspension of the team's manager for the next two (2) scheduled tournament games, even if those games are played at the next tournament level. Further penalties may be imposed if it is in the opinion of the Tournament Committee.**

27. Tournament Rule 12 [RUN RULE]: If at the end of three (3) innings [Intermediate (50-70) Division/Junior/Senior League: four (4) innings], two and one-half innings [Intermediate (50-70) Division/Junior/Senior League: three and one-half innings] if the home team is ahead, one team has a lead of fifteen (15) runs or more, the manager of the team with the least runs shall concede the victory to the opponent. If at the end of a regulation game one team has a lead of ten (10) runs or more, the manager of the team with the least runs shall concede the victory to the opponent.

NOTE 1: If the visiting team has a lead of fifteen (15) runs or ten (10) runs respectively, the home team must bat in its half of the inning.

NOTE 2: A game determined by the 15 or 10 run rule, shall be considered a regulation game.

NOTE 3: There is no <u>8-run rule in Tournament Play</u>, as outlined in Rule 4.10(e) for Regular Season only.
